Re: Protect the California Coast by Halting Offshore Fracking

On behalf of 129 environmental, social justice, indigenous and health organizations that collectively represent millions of members and supporters, we write to urge you to ban fracking off the California coast. We are disappointed that the federal government has proposed to end the current moratorium on hydraulic fracturing and acidization in federal waters off California. Fracking is a dangerous and dirty practice that pollutes our water and air and increases the threat of oil spills and earthquakes. It does not belong in our ocean.

Offshore fracking causes much environmental harm. First, oil companies dump their wastewater mixed with fracking chemicals into the ocean. Many of these chemicals are toxic to people and animals and pose a threat to California's marine life. Second, offshore fracking brings the same risks as onshore fracking — which has a bad track record of spills, accidents and earthquakes — with the added risks of the ocean environment. Third, fracking off the California coast will intensify offshore oil and gas development. Increased offshore drilling deepens our climate crisis and impedes our nation's ability to limit global warming to 1.5°C.

The Bureaus' flawed draft assessment acknowledges the risks of offshore fracking, but then largely ignores them. In so doing, the Bureaus failed to fully disclose the environmental impacts of their plan to allow oil companies to resume offshore fracking and other controversial drilling techniques. Moreover, the draft assessment concedes that there are unknown impacts, undisclosed chemicals, and data gaps; but illogically concludes that offshore fracking has no significant environmental impacts.

Given the known environmental and health hazards of fracking, as well as the information gaps of offshore fracking, we ask you to prohibit oil companies from fracking and acidizing wells off the California coast. At minimum, the Bureaus must continue the moratorium on fracking permits until the agencies prepare a full environmental impact statement that includes a comprehensive analysis of the environmental effects of offshore fracking. We believe that the public has a right to full disclosure of fracking's harmful impacts and that once aired there will be no choice but to halt fracking.

Please protect the California coast from dangerous drilling and fracking.
